Ahmedabad International School, Judges Bungalow Road, Bodakdev, Ahmedabad – 380 015, for the Academic Year : 2021-22 for Grade 1 to 7 (IB PYP), Grade 8 to 10 (GSEB), Grade 8 to 10 (CAIE), Grade 11 & 12 (GSEB), AS & A Level (CAIE) and IBDP 1 & 2 (IB), along with relevant documents. After considering the said proposal and the documents attached therewith, the committee has passed the provisional order on 14.03.2022 for the academic year : 2021-22 for Grade 1 to 7 (IB PYP), Grade 8 to 10 (GSEB), Grade 8 to 10 (CAIE), Grade 11 & 12

(GSEB), AS & A Level (CAIE) and IBDP 1 & 2 (IB), For Gr. 1 Rs.104000/- against Rs.137500/-, For Gr. 2 to 7 Rs.98500/- against Rs.137500/- (IB PYP), For Gr. 8 & 9 Rs.81000/- against Rs.121000/-, For Gr. 10 Rs.75250/- against Rs.121000/- (GSEB), For Gr. 8 to 10 Rs.144700/- against Rs.176000/- (CAIE), For Gr. 11 & 12 Rs.75250/- against Rs.121000/- (GSEB), For AS Level & A Level (CAIE) (IGCSE) Rs.231500/- against Rs.495000/-, For IDBP 1 & IDBP 2 (IB) Rs.231500/- against Rs.495000/- (GSEB) for the academic year : 2021-22.

2. On receipt of said order, the school has raised its objection while its letter dated 06.04.2022 and also School representative Minesh A. Shah (Trustee) and Vidhi R. Shah (C.A.) of the school Present and also additional submission submitted on dated 15.06.2022, in written that the impugned provisional order passed by the FRC based on the fee determined by the FRC for the year : 2017-18 & 2018-19, which is subject matter of SCA – 14719 of 2019, before the Hon. Gujarat High Court, Ahmedabad. The matter is subjudice as on today.
3. Moreover school requested that due to matter is subjudice before the Hon. Gujarat High Court, the provisional order and keep the final order in abeyance till the final disposal of SCA of 14719 of 2019. In further school undertake to give necessary effect on school fees taken recovered by the applicant school. on the final outcome of the SCA No. 14719 of 2019 and we also appeared before the Hon. FRC, Ahmedabad zone on final outcome of SCA for the fresh hearing for the fee determination with fresh merit and supported documents and evidence.
- 1 After gone through the above submission and document which ever submitted by the school representative its become clear that earlier order of FRC of the year : 2017-18 & 2018-19 challenge by the Ahmedabad International School, Judges Bungalow Road, Bodakdev, Ahmedabad – 380 015 under the SCA 14719 of 2019, before the Hon. High Court of Gujarat. Hence Committee is agreed with the Humble submission of school representative to kept provisional and final order for the A.Y : 2021-22 in abeyance till the final outcome disposed of matter before the Hon. Gujarat High Court. On following conditions.
  - (1) The School is directed to keep updated on every month about the status of the case matter of SCA No. 14719 of 2019, before the FRC till final disposal.

(2) School is directed to submit detailed statement of collecting its fee since the Year : 2017-18 to up till the date, with list of outgoing student's during above pending matters before the Hon. Gujarat High Court.

(3) School is permitted as per the request and under taken to appeared before the FRC, Ahmedabad Zone on final outcome of SCA No. 14719 of 2019. for the fresh hearing for the A.Y : 2021-22, 2022-23. Which ever order passed by Hon. Gujarat High Court.


(4) The School is directed to place the above order on its notice board as well as its website in both language respectively in Gujarati and English.
